LICENSE FOR THE POSSESSION OF METHYL ALCOHOL FOR BUSINESS PURPOSE IN EXCESS OF THE QUANTITY FIXED AS THE LIMIT FOR PRIVATE POSSESSION.


*M/S Dey's Medical Stores (Mfg) Ltd* resident of *8, Rifle Range Road, Kolkata -700019.* Thana *karaya* District- *Kolkata (South)* is hereby authorized by the undersigned, the Collector of Excise, Kolkata (South) to possess *Methyl Alcohol 1,20,000 (One Lakh Twenty Thousand)* bulk litres of Methyl Alcohol for the purpose of *Chloramphenicol* at *8, Rifle Range Road, Kolkata -700019* from *01.04.2023.* to *31.03.2024.*

It is required of the holder of this license as a condition of its remaining in force that he duly and faithfully perform and abide by the following conditions and by the special conditions (if any) as have been prescribed in the case of this license by the Collector of Excise, Kolkata (South) and endorsed on the same.

- I. That he receive no Methyl Alcohol under this license unless conveyed by a pass granted by a duly authorized officer which must accompany the Methyl Alcohol during transit.
- II. That he do not possess any Methyl Alcohol in excess of one gallon of six reputed quart bottles in any premises other than those covered by the license.
- III. That he do not at one time sell Methyl Alcohol.
- IV. That he store Methyl Alcohol only in a room built of unflammable material and well ventilated; that he allow no naked lights or fire to be used or kept in such room and that he keep all receptacles containing such spirits closed so as to prevent the accumulation of spirits fumes in the room.
- V. That he allow any excise officer of or above the rank of sub-inspector to enter into and remain upon the premises covered by this license so long as may be necessary for the proper execution of his duties, that he permit such officer to examine, test and measure his stock of denatured spirits and that he do not obstruct any such officer in the performance of his duties.

N.B. – Infraction of any of above conditions or of the general condition applicable to excise and opium vend licenses will subject the holder of the license to forfeiture of the license and to all or any of the penalties prescribed by the law or rule.
