PERMIT TO OBTAIN RECTIFIED SPIRIT/ABSOLUTE ALCOHOL FROM A DISTILLERY OR WAREHOUSE ON PAYMENT OF DUTY AT THE RATE OF RUPEES twenty only PER LONDONPROOF LITRE FOR ANALYTICAL PURPOSE

are hereby permitted by the undersigned, the Collector of Excise, Kolkata (South) to obtain from a licensed distillery or warehouse Rectified Spirit/Absolute Alcohol on payment of duty at the rate of 20/- per London Proof Litre up to a maximum of 400BL R/S.A/A each bulk litres per annum and is quantities of not less than 200BL R/S.A/A each bulk litres or more than.....Bulk Litres at a time for analytical purpose for use in making from 01.04.2023. to 31.03.2024.

It is required of the holder of this permit, as a conditions of its remaining in force, that he/they shall duly and faithfully perform and abide by the following conditions and also by such special conditions as may be imposed by the Collector of Excise, Kolkata (South) and specified here in after: -

1. That he/they shall be bound by the provisions of the Bengal Excise Act (Act V) of 1909 and of all the rules framed there under that may be in force at any time during the currency of this permit, in so far as such provisions may be applicable to this permit, and also by all the orders which may be issued from time to time by the State Government or the Collector of Excise, Kolkata (South), West Bengal in connection with the supply, storage and use of Rectified Spirit/Absolute Alcohol (here in after referred to as the Spirit) and shall cause all persons employed by him/them to obey such orders.
2. That he/they shall store and use the spirit only on the premises approved in this behalf and specified above and shall not remove the spirit there from except with the previous permission of, and save under such conditions as may be imposed by the Collector of Excise, Kolkata (South), West Bengal.
3. That he /they shall submit the Superintendent of Excise, every time supply of the spirit is required. A registration in the prescribed form together with this permit and obtain the sanction of the Superintendent to the supply in the form approved hereto.
4. That he /they shall use the spirit solely for the ~~industrial~~ Analytical purpose detailed above.
5. That he/they shall take supply of the spirit from a distillery or warehouse in vessels sealed by the Excise Officer-in-Charge with his official seal and shall remove the spirit under cover of a pass granted by that Officer.
6. That he/they shall keep the vessels containing the spirit with the Excise seals intact in a secure place under lock and key in charge of a responsible person approved by the Collector of Excise, Kolkata (South), and shall not open any of the vessels unit its contents haveto be drawn for use or for examination by an Excise Officer or for transfer to another vessel in an emergency.
7. That he/they shall not purify the spirit by re distillation or otherwise before use.

8. That he/they shall not recover the spirit in course of manufacture or otherwise except with the previous permission of the Collector of Excise and save under such special conditions as may be laid down by him and shall keep the recovered spirit separately under lock and key in charge of a responsible persons approved by the Collector of Excise, Kolkata (South), West Bengal.
9. That unless he/they is/are permitted to recover spirit, as/they shall keep spirit which are unfit for use in a separate receptacle a secure place under lock and key and shall destroy the stock of spirits so accumulated in the presence of an Excise Officer.
10. That he/they pay duty at the full rate prescribed for Rectified spirit on any quantity of the spirit or any plain spirit derived there from which may not be properly used or satisfactorily accounted for any on any wastage of spirit which may in the opinion of the Collector of Excise be excessive.
11. That he/they shall give full facility during working hours to an Excise Officer not below the rank of Sub-inspector of Excise to inspect the premises in respect of which this permit is granted, to take stock of all spirits and to examine the prescribed accounts and also all relevant business records.
12. That on determination of this permit he/they shall, unless the stock of all unusable spirits is liable to seizure, deposit for safe custody and dispose of the entire stock of such spirits, if any in such manner as the Collector of Excise, Kolkata (South), West Bengal.
13. That as security for fulfilment of conditions 1, 2, 4,6,7,8, 9, 10, 11 and 12 set forth above and of the special conditions below they shall execute a bond in the prescribed form for such amount at the Commissioner of Excise may deem adequate.

Special Conditions

F.B.: -Information of any of the above ordinary conditions will subject the holder(s) of this permit to forfeiture of the permit and so all or any of the penalties prescribed by law or rule.
