Special permit for use of rectified spirit obtained at concession rate of duty for purpose of research work and of chemical analysis in laboratories etc.

M/S Dey's Medical Stores (Mfg) Pvt. Ltd,
62 Bondel Road,
Kolkata - 700019.

Is hereby permitted to obtain Rectified Spirit/Absolute Alcohol at the concession rate duty of Rs. 20/- per London Proof Litre up to a maximum limit of 320 each R/S & A/A bulk litres yearly, 28.184 each R/S & A/A bulk litres at-a-time subject to the following conditions:-

1. That they are such spirit solely for purpose for which sanction to obtain spirit at concession rate of duty has been granted.
2. That he /they shall submit every time supply of the spirit is wanted a requisition for supply of spirit in the prescribed form to the Special Superintendent of Excise, Special Section, along with the permit and obtain his for the supply.
3. That they shall take supply of the spirit under cover of a Pass to be granted by the Officer-in-charge of Distillery or Warehouse.
4. That they shall store the spirit so obtained in casks, vats or other approved receptacles which shall be kept in secure place under a Special lock and key of the permit holder or manager appointed by him and approved by the Collector of Excise, Kolkata (South), West Bengal.
5. That they shall execute a security bond for use of spirit obtained at concession rate of duty.
6. That they shall keep a regular daily correct account of such spirit and medicine manufactured with the same according to forms prescribed from time to time by the Collector of Excise, Kolkata (South), West Bengal.
7. That they shall give full facility to an Excise Officer authorised by the Collector of Excise, Kolkata (South), West Bengal. to make stock of Spirit and to check the accounts of Spirit and to check the account of spirit, during the usual working hours viz. From 10 A.M. in the morning to 5 P.M. in the evening.
